

The Marion County Board of Supervisors met January 3, 2023 at 3014 E Main St., Knoxville, IA for their annual Organizational Meeting with Kisha Jahner, Steve McCombs, and Mark Raymie present.

Unless otherwise indicated, all the motions offered at this meeting were carried with the following vote:

Ayes: Jahner, McCombs, and Raymie Nays: none. Abstentions: none. Absent: none.

1. Jake Grandia, Marion County Auditor, called the meeting to order at 9:00 A.M. Grandia then entertained motions for Chair of the Marion County Board of Supervisors for the year of 2023. Raymie moved and McCombs seconded for approval of Kisha Jahner as 2023 Marion County Board of Supervisor Chair with authorization to sign for Official County Business.

Chairman Jahner then assumed leadership of the meeting at 9:02 A.M.

2. Raymie moved and Jahner seconded for approval of Steve McCombs as 2023 Vice-Chair of the Marion County Board of Supervisors with authorization to sign for Official County Business.

3. Raymie moved and McCombs seconded the official regular sessions of the Board of Supervisors be set for the 2nd and 4th Tuesday of every month at 9:00 A.M.

4. McCombs moved and Raymie seconded to designate the Marion County Express newspaper for official County public notices. Marion County Attorney Ed Bull indicated the Official Request from Marion County Express did not list out all the required detail but had no reason to believe they didn't meet the requirements.

5. McCombs moved and Raymie seconded to approve Resolution 2023-1 authorizing maximum depository thresholds as follows:

Whereas, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

Whereas, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2023 and January 31, 2024 and submit an adopted recommendation regarding that application to the DNR; and

Whereas, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

Now, Therefore, Be It Resolved By The Board Of Supervisors Of Marion County that the Board of Supervisors hereby adopts this construction evaluation resolution Pursuant to Iowa Code section 459.304(3).


