

FACTS ABOUT LEVY RATES

Levy rates are also known as Millage rates and Tax rates.

Levy rates are applied against TAXABLE values, not Assessed values.

The enclosed Levy rates are shown as Dollars of taxes per One-Thousand dollars of TAXABLE value.

Taxable values are a percentage of the Assessed value; this percentage is called a Rollback.

Rollback percentages are determined and set by the State of Iowa, not local governing bodies.

Each class of property (Residential, Commercial, Industrial, and Agriculture) has a separate Rollback percentage. These Rollback percentages are calculated and set each tax year.

The Rollback percentages are used by the State of Iowa to control the growth of taxable values on a state-wide basis, not a county basis.

Levy rates are not themselves set by local governing bodies. Levy rates are a product of the calculation of the total of the budgets set by local governments divided by the total amount of taxable value available for taxation. The governing body generally has a pretty good idea of what their levy rate will be when they finalize their budget.

It is difficult to compare urban tax district levy rates relative to each other without knowing the size of the district tax base, the property class makeup of the tax base, and the budgets of the city and the school district.

For most properties, the school district accounts for the largest portion of their tax bill.

The tax statement provides a break-down of where each tax dollar goes, and a comparison to the previous year.

Some local government budgets have maximum levy rates set by the Code of Iowa. This, along with taxable values, controls the maximum amount of those budgets.
