Whereas, the Marion County Board of Supervisors believe it is in the best interest of the taxpayers of Marion County to supplement the annual debt service principal and interest payment on the Marion County Law Enforcement Center with funds from the proceeds of the Local Option Sales and Services Tax (LOSST) collected in Marion County. The Board approved in the Fiscal Year 2006-2007 budget to

use \$300,000 LOSST Funds to reduce the required debt service levy to fund the construction of the Marion County Law Enforcement Center.

Therefore, Be It Resolved that the transfer of funds from the Marion County Local Option Sales and Services Fund to the Marion County Debt Service Fund be approved by the Marion County Board of Supervisors for the Fiscal Year of 2006/2007, and,

Be It Further Resolved, that the Auditor and Treasurer be instructed to make the said transfer in a timely fashion equal to the amount of the approved budgeted transfer of \$300,000.

Whereas, the CIETC Board has served as the Local Elected Official (LEO) and Grant Recipient under and pursuant to the terms of the Workforce Investment Act of 1998, as amended ("WIA") for the Iowa Workforce Investment Region XI; and

Whereas, the CIETC Board entered into a Regional Grant Agreement with the Iowa Workforce Development Department ("IWD"), pursuant to which CIETC was designated as the Service Provider, Fiscal Agent, and administrator of various programs and funds for employment training and related activities within that Region XI, including the Promise Jobs program, all under the supervision of IWD and the United States Department of Labor; and

Whereas, IWD removed from CIETC its former Fiscal Agent responsibilities; and

Whereas, IWD notified the CIETC Board that, unless the CIETC Board, as the LEO, selected an alternative Service Provider within an arbitrary and constrained timeframe, IWD would remove from CIETC its Promise Jobs program administration; and

Whereas, without funds from the Promise Jobs program, CIETC would be unable to cover its costs of operational and administrative overhead deemed necessary to carry on remaining activities, retain employees, and deliver services to individuals in need of employment-related services; and

Whereas, the CIETC Board published invitations for proposals from agencies qualified to assume, and interested in assuming, the role and responsibilities of Service Provider and Fiscal Agent for Region XI; received and considered two proposals; received and considered the recommendation of the Regional Workforce Investment Board ("RWIB"); selected the Des Moines Area Community College ("DMACC") to serve in both capacities; and authorized legal counsel to draft a contract to document the foregoing; and

Whereas, the contractual arrangement with DMACC has been finalized;

Whereas, the contract will significantly realign responsibilities for service delivery and oversight in Region XI for employment training and related activities; will alter the nature and scope of functions and activities within the province of CIETC; and, given the provisions of paragraph 9 of the existing 28E Agreement, the foregoing developments represent an occasion that requires the CIETC 28E Agreement to be revisited; and

Whereas, the CIETC Board has expressed a commitment to the uninterrupted continuation of programs and services for the benefit of CIETC employees and program recipients that is shared by the CIETC member governments;

Be It Therefore Resolved that, subject to approval of all other CIETC member governments to be served within Region XI, the Board of Supervisors of Marion County hereby adopts the following:

- 1. That the existing CIETC 28E Agreement be terminated and CIETC be dissolved as a corporate body politic.

That the CIETC board members and officers, in cooperation with legal counsel, proceed with winding up the affairs of CIETC as expeditiously as can be prudently accomplished, including without limitation, authority to transfer CIETC employees and personnel records to DMACC pursuant to the approved contract; to deposit with DMACC from CIETC's available funds the resources necessary

to cover the accrued PTO of CIETC employees; to assign any and all leases and/or ownership of real and personal property to DMACC pursuant to the approved contract; to assign other contracts, claims, defense, off-sets, and causes of action as appropriate; to transfer books and records to DMACC regarding programs previously administered by CIETC, including records relating to individual program recipients; and to provide notice of the dissolution to third parties, including other governmental boards and agencies.

- 3. That the accompanying, new 28E Agreement under the name "Regional Workforce Investment Alliance ("RWIA") be adopted, executed, and duly filed and recorded as provided by law as soon as practicable following the approval of a like resolution by all of the other CIETC member governments to be served within Region XI.
- 4. That RWIA will be the LEO as contemplated by the WIA, instead of CIETC being the LEO as it has been.
- 5. That upon such adoption, execution, and recording, notice shall be given to other governmental boards and agencies.
- 6. That a new Memorandum of Understanding be negotiated and finalized between RWIA and RWIB.
- 7. That the Board Chairperson be, and is hereby, authorized to execute such documents and do such things as may be deemed necessary to effectuate the foregoing as seamlessly as possible and with the least possible disruption to the uninterrupted delivery of needed services to program recipients, including without limitation the execution of the new 28E Agreement for RWIA.

1.) Marion County Board of Supervisors/Secondary Road Department – The Marion County Board of Supervisors is considering a proposal to relocate the county Secondary Road shop currently located in Pella.

The current facility in Pella was constructed in 1968. At the time and up until 2005 this facility housed a multifunctional crew of county workers serving the area North of Lake Red Rock. In 2005 the county reorganized the Secondary Road Department and now has two geographical districts, one east and one west of highway 14. These districts are responsible for maintaining rural rock surfaced roads. These crews are primarily housed in the Franklin and Clay Township facilities with smaller satellite shops in Columbia, Bussey and Otley. The Pella facility, located inside the city limits of Pella, now houses a crew responsible for the maintenance of bridges and pavements throughout the entire county.

A site is under consideration that would relocate this crew closer to the center of the county's paved roads system, thereby allowing for greater efficiency. The site being considered is large enough to allow the county to consider further consolidation of facilities as well, including the Clay Township operations. At some future date, should the need arise, the relocation of the Central shop and office complex in Knoxville could be accommodated as well.

The site under consideration is near the intersection of Old Highway 92 and New Highway 92. New facilities would be constructed at the location for salt storage and to provide under-roof space for personnel and equipment. The facilities in Pella would be sold to help fund the new facilities. It is anticipated a new site and new facilities will cost approximately \$475,000 to replace the Pella Facility only. A value of the Pella Property has not yet been established. At least one appraisal will be acquired to help establish value. It is anticipated a substantial portion of the cost could be funded by the sale of the Pella property.

Marion County Engineer Roger Schletzbaum gave an overview of the proposed plan. Comments were received from the public. The Auditor's Office had not received any written comment from the public.
