The County must pass the support Resolution to make it possible for other jurisdictions in the County to become members. The EDD will assist in grant writing and administrative services with any U.S. Economic Development Administration funding opportunities. The Board will consider the Resolution in the next meeting. Jahner moved and McCombs seconded to close discussion.

4. Leslie Vander Linden, Marion County Humane Society, presented a request for additional County funding of the Marion County Humane Society. Discussion included usage counts, other jurisdiction funding levels, operational costs, and State requirements. The Board will consider the request in the next meeting.
