1. Marion County Zoning Director Missy Poffenbarger presented Zoning Petition #2022-897 from Columbia Land Company requesting approval of a Minor Plat of Subdivision referred to as "Minor Subdivision of Parcel D". McCombs moved and Jahner seconded to approve the Minor Subdivision. Resolution 2022-81 approves as follows:

- 4. The Board held discussion regarding building usage at Marion County properties 3014 E. Main, 104 S. 6th, and 2003 N. Lincoln in Knoxville due to the new space availability in the Public Health offices. The Board had consensus regarding future disposition of the 104 S 6th location. Comments regarding office space needs were received by the following departments: HR, Economic Development, EMA, Zoning, IT and Mental Health. Jahner moved and McCombs seconded to close discussion.
- 5. Marion County Development Director Carla Eysink answered questions from the Board regarding proposed Resolution 2022-82 requesting assistance from the City of Knoxville in applying for a Nuisance Property and Abandoned Building Remediation loan for the VA Campus laundry building. The Iowa Economic Development Authority has indicated the loan will be forgivable. Eysink was requested to get a copy of this direction from IEDA in writing. Marion County Facilities Director Chris Nesteby indicated the funds would be used to get utilities to the building, remove all old equipment and make weather tight. The status of any possible RIF funds were discussed with the outlook not positive. McCombs moved and Jahner seconded to approve the Resolution as presented and follows:

Whereas, Marion County and the City of Knoxville have been working in partnership to redevelop the former VA Lands; and

Whereas, Marion County has invested considerable funds in the acquisition of the VA property, including the demolition of obsolete buildings and infrastructure; and

Whereas, Marion County, in choosing to retain the former VA Building, recognized the inherent economic value within the building; and

Whereas, the estimated cost of removing the existing industrial laundry equipment from the building, undertaking minor building repairs, and installing new utility connections is \$505,920 and

Whereas, the Iowa Economic Development Authority (IEDA) offers interest-free loans to assist municipalities in rehabilitating abandoned buildings under the Nuisance Property & Abandoned Building Remediation program; and

Whereas, IEDA has indicated that they are able and willing to forgive such a loan for the former laundry building; and

Whereas, Marion County is unable to apply for this loan, but the City of Knoxville may do so on the County's behalf; and

Whereas, City of Knoxville officials have indicated a willingness to present to their City Council a request from Marion County to apply for this loan, subject to County's commitment to be responsible for repayment of the loan until such time as IEDA forgives the loan, management of the project and its costs, and the provision of the required information to allow the City to apply for loan forgiveness:

Now Therefore, Be It Resolved, The Marion County Board of Supervisors request the City of Knoxville's assistance in applying for a Nuisance Property & Abandoned Building Remediation loan as described herein.
