At the Marion County Conservation Board's recent November 21, 2023 Board Meeting, the County Conservation Board Members unanimously recommended that a request be made to the Marion County Board of Supervisors to have Mr. Bill Shepherd of Knoxville, who's term expires on December 31, 2023, be reappointed to the Conservation Board.

Mr. Shepherd was appointed to the Conservation Board in July of 2021 to fill the unexpired term of Mr. Will Prather who resigned from the Board due to health reasons at the end of April of that year.
